

Column Title	Explanation of Entries
App No	This is the number linked to your application. Once your application has been approved this will become your license number.
Type	This is the classification of license you have applied for. CDR – For-Hire Vehicle Operator HDR – Medallion /For-Hire Vehicle Operator PDR – Paratransit Vehicle Operator VDR – Commuter Van Vehicle Operator
App Date	The date you submitted your application.
Status	The stage of the review process that your application is currently in: - “Incomplete” : Your application is missing requirements. Courtesy reminders are being sent by mail/email/text. If needed you can contact the Call Center for more information. - “Pending Fitness Interview” : Your application has been forwarded to the Fitness Review Unit for a Fitness Interview. See the next column for interview date if available. - “Denied” : Your application has been denied. Contact the Call Center or watch your mail for more information. - “Under Review” : Your application is still being processed. - “Approved – License Issued” : Your application has been approved and your license will be mailed to the address provided on your application.
FRU Interview Scheduled	Fitness Review Unit Interview: “Not Applicable” if no Fitness Review is necessary. -OR- If there is a date, a Fitness Interview has been scheduled. Please contact the Call Center or watch your mail/email for more information.
Drug Test	Drug testing is required for Medallion and FHV TLC driver’s licenses. If the entry is: - “Needed” : your drug test information is not in our system. If you have not taken your drug test please do so immediately. If you have taken your drug test please contact the Call Center and provide the “Chain of Custody” serial number provided by LabCorp. - “Not Applicable” : If you applied for a Paratransit or Commuter Van license you do not need to take a TLC Drug Test. - “Complete” : Your drug test information has been received and updated in your TLC record. WAV Course	Wheelchair Accessible Vehicle Training (WAV) is a requirement for those who apply for a Medallion or For-Hire Vehicle driver’s license. If the entry is: - “Needed” : Your WAV training information is not in our system. If you have not taken your WAV training please, do so immediately. If you have taken your training, please contact the Call Center and provide your date of completion and the school where you received your training. - “Not Applicable” : If you applied for a Paratransit or Commuter Van license you will not need to take this training. - “Complete” : Your WAV training information has been received and updated in your TLC record. Defensive Driving	A NYS certified 6 hour Defensive Driving Course is a requirement to receive your TLC license.

<p>Driver Exam</p>	<p>Upon Completion of TLC Driver Training (Taxi School), you will need to take and pass a final exam. Passing score is 70%.</p> <p>If the entry is:</p> <ul style="list-style-type: none"> -“Needed”: Your TLC Driver Exam information is not in our system. If you have not taken your TLC Driver Exam please do so immediately. If you have taken your Exam, please contact the Call Center and provide the date and the school where you took your exam. -“Not Applicable”: If you applied for a Paratransit or Commuter Van license you will not need to take this exam. -“Complete”: Your TLC Driver Exam information has been received and updated in your TLC record.
<p>Medical Clearance Form</p>	<p>A Medical Clearance form from a licensed medical doctor is a requirement for those who apply for a Medallion or a For-Hire Vehicle driver’s license.</p> <p>If the entry is:</p> <ul style="list-style-type: none"> -“Needed”: Your Medical Clearance form is not in our system. If you have not been medically cleared by a licensed medical doctor please do so immediately. If you have been medically cleared to apply, please contact the Call Center and provide your Information. -“Not Applicable”: If you applied for a Paratransit or Commuter Van license you will not need to take this step as it is covered by your 19A status. -“Complete”: Your Medical Clearance has been received and updated in your TLC record. <p>To download the Medical Clearance form, please visit http://www.nyc.gov/html/tlc/downloads/pdf/driver_medical_form_b.pdf.</p>
