

# HPD Open Data

## Registrations

Pursuant to New York City's Housing Maintenance Code, the Department of Housing Preservation and Development (HPD) collects registration information from owners of residential rental units. Owners are required to register if they own residential buildings with three or more units or if they own one- or two-family homes and neither they nor members of their immediate family live there. Registrations are required upon taking ownership of a qualifying building, and once a year thereafter.

The registration information in this file is updated quarterly, normally as of April 30, July 31, October 30 and January 31. Each file will contain the information from the last valid registration at the time of the file posting. A valid registration is one in which all of the appropriate data is supplied. Each registration will also display an expiration date. If the expiration date has passed, the property registration is not **current**. The law requires HPD to mail Notices of Violation to the owner using the last valid registration, even if that property registration is not current. A property registration must be valid and current for the property to be in compliance with the law. In order to determine which registration in a previous file may be replaced by a registration in a new file, the building being registered is uniquely identified by an XML element called BuildingID (full XML path: //RegistrationOpenData/Registrations/Registration/BuildingID). Use this value to link new registrations with any history you are maintaining in your own datastore.

Starting with the September, 2012 release a registration may apply to more than one building (so-called Garden Complexes). In such cases, there will be more than one Registration element with the same RegistrationID. However, each such element will have a different BuildingID and other building-specific information, such as address, BBL and BIN.

### Data Dictionary

The Registration information is structured as XML. Schema files defining the XML format are included in the zip package containing this file. The root schema file is called "services.hpd.gov.xsd". The XML structure is pretty simple, containing the following major elements

- InformationURL – an url where related information can be found
- SourceAgency – the agency providing the data (HPD)
- SourceSystem – the agency's system for managing the data
- StartDate – the start date of the period covered by the file

The RegistrationOpenData element is the root element and contains some descriptive elements as well as the Registrations collection, which contains Registration elements. Each Registration element contains elements about the building and the registration, as well as the Contacts collection, which contains RegistrationContact elements. Each RegistrationContact element contains elements about a person or organization identified on the registration form.
